ORDER

Consequent to the order in Notification No. 5 dated 15.11.2014 of the Principal Chief Commissioner of Income-tax, Tamilnadu in C. No. CHE/COORD/112(2)/JURSDN/2014-15, the designation of the Commissioner of Income-tax (Appeals) having jurisdiction over persons, assessed in Corporate Range – 1, Non Corporate Range – 1, Non Corporate Range- 2, Corporate Range – 5, Non Corporate Range – 3, Non Corporate Range -4 , Non Corporate Range -5, Non Corporate Range – 6, Chennai were modified. The Appeals pending before the erstwhile CIT(Appeals) -I, CIT (Appeals) -IV, CIT(Appeals) - V and CIT(Appeals) - VI Chennai are now bifurcated between newly created CIT(Appeals) -1, CIT(Appeals) -2, CIT (Appeals) -3, CIT(Appeals) -4, and CIT (Appeals)-5, Chennai.

- CIT (Appeals)-1 has jurisdiction over persons assessed in Corporate Range –1 and Special Range -1.
- CIT (Appeals)-2 has jurisdiction over persons assessed in Non Corporate Range – 1 and Non Corporate Range -2.
- CIT (Appeals)-3 has jurisdiction over persons assessed in Corporate Range –5 and Special Range-5.
- CIT (Appeals)-4 has jurisdiction over persons assessed in Non-Corporate Range – 3, Special Range -3 and Non-Corporate Range – 16 .
- CIT (Appeals)-5 has jurisdiction over persons assessed in Non-Corporate Range – 4, Non Corporate Range – 5, Non-Corporate Range – 6 and Non Corporate Range - 17.

In order to ascertain the present jurisdiction of the pending appeals, in the case of any given assessee, the details of old ITA No. and the corresponding new ITA No. are given in a tabular form. Appellants are requested to quote the new ITA No. in all communication, and contact the new Jurisdictional Appellate Commissioners.

This issues with the approval of the Chief Commissioner of Income-tax – 1, Chennai.
