ORDER

Consequent to the order in Notification No. 5 dated 15.11.2014 of the Principal Chief Commissioner of Income Tax, Tamil Nadu in C. No. CHE/COORD/112(2)/JURSDN/2014-15, the designation of the Commissioner of Income-tax(Appeals) having jurisdiction over persons, assessed in Corporate Range-3, Special Range-3, Non-Corporate Range-10, Non-Corporate-19, Special Range-8, Non-Corporate Range-11, Non-Corporate Range-12, Vellore Range, Special Range-9, Non-Corporate Range-13, Non-Corporate Range-14 and Non-Corporate Range-20. The appeals pending before the erstwhile CIT(Appeals)-3 have been trifurcated among the newly created CIT(Appeals)-11, CIT(Appeals)-12 and CIT(Appeals)-13. A part of the pending appeals before the erstwhile CIT(Appeals)-2 and CIT(Appeals)-4 were assigned to the newly created CIT(Appeals)-14, Chennai.

- CIT(Appeals)-11 has jurisdiction over persons assessed in Corporate Range-3 and Special Range-3
- CIT(Appeals)-12 has jurisdiction over persons assessed in Non Corporate Range-10 and Non Corporate Range-19
- CIT(Appeals)-13 has jurisdiction over persons assessed in Special Range-8, Non Corporate Range-11 and Non Corporate Range-12
- CIT(Appeals)-14 has jurisdiction over persons assessed in Special Range-9 Non Corporate Range-13 and Non Corporate Range-14 and Non Corporate Range 20

In order to ascertain the present jurisdiction of the pending appeals, in the case of any given assessee, the details of old ITA No. and the corresponding new ITA No. are given in a tabular form. Appellants are requested to quote the new ITA No. in all communication and contact the new jurisdictional Appellate Commissioners.
